\*\*Reporting of APPR, EPPR, and PPPR will now go to BOT in February rather than October; deadlines have been adjusted accordingly.

Note: THEC Academic Program Productivity Reporting is typically due on May 1 (along with the Post-Approval Monitoring Report). This report is due every three years, and 2021 was the last reporting cycle, with 2024 being the next. However, as of January 2024, THEC has indicated that changes to the reporting process and timeline are under review and will likely change, so additional information will not be available until later in the year.

#### **NOTES**

- The dates listed above do not reflect any campus deadlines or approvals.
- Items requested to appear on the UT Board of Trustees meeting agenda must be received by AARSS in complete draft form at least **2 months prior** (to the day) of the upcoming BOT meeting.
- ➤ The UT System Office of AARSS must receive all complete and final versions of BOT materials no later than **6 weeks before** the upcoming BOT meeting. Example: For a new academic program, May 13, 2024, is the deadline for UT System staff in AARSS to receive all completed BOT materials for the June 24, 2024, meeting.
- Please direct all communications about academic or student affairs issues going before the Board of Trustees to the appropriate ERS committee System Office staff in AARSS. Requests are not to be made directly to the system president, a trustee, or the secretary to the board.
- > Submitting a request before the deadline does not guarantee that the item will appear on the requested Board of Trustees meeting agenda. All requirements, including responses to external reviewers and final THEC staff approval, must be met for an item to proceed to the board agenda.
